

RESOLUTION NO. 2025 - 01

A RESOLUTION AUTHORIZING THE CLERK TREASURER TO ENCUMBER FUNDS

WHEREAS, The Town of Shadeland in Tippecanoe County, ("Town") is an Indiana Municipality governed by its duly elected Town Council ("Council");

WHEREAS, the Council has the authority and duty to maintain and oversee the fiscal operations of the Town and to reconcile the Town's financial and budgetary records;

WHEREAS, the Town has various funds that the services or products have not yet been paid as provided for in Exhibit A;

WHEREAS, pursuant to recommendations from the Clerk Treasurer in order to complete these projects, programs, or purchases using funding set aside in previous fiscal years and in order to be consistent with Indiana law and Indiana Department of Local Government Finance ("DLGF") procedures, this action must be pursuant to a resolution adopted by the Council.

NOW, THEREFORE, BE IS RESOLVED by the Town Council meeting in regular session as follows:

**Section 1.** That those certain Town funds and purchase orders as identified on Exhibit A attached hereto and made a part hereof are hereby encumbered.

**Section 2.** The Clerk Treasurer is hereby directed to encumber the monies for said accounts.

**Section 3.** This Resolution shall be in full force and effect retroactive to December 31, 2024.



